OLD BUSINESS

New Station. The Trustee reported that Cripe is looking into the feasibility of onsite well and sceptic for the new station. There have been and are challenges with municipal utilities. All agree that self-containment would be the best option if the site will accommodate. Mrs. Cook informed the Board that Sonny and Scott Beck have been informed of this development. They have indicated that a well should pose no problems or issues. They, along with the rest of us, are awaiting specifics regarding a septic system.

Reorganization. The Trustee reported that the Town of Cicero has retained legal counsel and should be moving forward with a decision on whether to proceed soon. Mrs. Cook reported that she met with the City of Westfield Mayor, Scott Willis, Dr's Arrowood (HHSC) and Mundy (SCS), Dan Strong (Town of Cicero), Jack Russell (One Zone) and Mark Heirbrandt (County Commissioner). Mayor Willis stated that he has no intention to aggressively annex into Jackson and Adams Township. In addition, he offered to help the communities with their respective reorganizations if needed.






